Subject: **ENLISTMENT OF M/S KARACHI SHIPYARD & ENGINEERING WORKS, KARACHI WITH OGRA AS AUTHORIZED MANUFACTURER OF LPG STORAGE TANKS/ LPG BULLETS/ LPG BOWSERS**

Dear Sir,

Please refer to the above subject.

2. The Oil and Gas Regulatory Authority is pleased to inform you that your company has been enlisted as OGRA's authorized manufacturer of LPG Storage Tanks/ LPG Bullets/ LPG Bowsers till 31st December, 2024, for supply to only licensed LPG companies, in pursuance of Section-6 (2)(e)(f)(y) of OGRA Ordinance, 2002, Appendix-I of LPG Rules, 2001 (specifying LPG Equipment Standards) and LPG Policies received from the Federal Government, from time to time, subject to the following terms and conditions: -
- You shall strictly adhere to and follow the applicable qualifying standard as per LPG Rules, 2001 at all the times while manufacturing the subject LPG Storage Tanks/ LPG Bullets/ LPG Bowsers. OGRA has the right to cancel your enlistment at any time when it has been established through an inspection conducted by its appointed inspector that the manufacturing process or method, is substandard or any substandard material has been used in manufacturing.
 - You shall manufacture and sell the subject LPG Storage Tanks/ LPG Bullets/ LPG Bowsers to the licensed LPG companies. Name/ complete addresses of the buyer shall be furnished to OGRA on bi-annual basis for record.
 - You shall keep an updated record of all manufacturing / manufactured items along with details of clients for the purpose of audit if required by the Authority or its representative from time to time.
 - This pre-qualification does not relieve the company of its obligation to execute the works at its manufacturing facility in accordance with best engineering practices; and adopting all safety measures as well as all the applicable Laws / Rules.
 - In case of any accident due to manufacturing defect or fault of the equipment as verified by the 3rd party inspector (s), the manufacturer shall be responsible to pay compensation to the affectees as determined by Authority.
 - The subject registration shall be renewed on yearly basis after re-inspection carried out by OGRA's designated 3rd party inspector. The annual renewal /registration fee is Rs. 300,000/- which is required to be submitted by your company in favor of OGRA before 15th December each year failing which your company would be de-listed from the authorized manufacturers list.
 - In case of de-listment your company will have to follow the whole process again after depositing the renewal fees of lapse period (i.e., duration from fee due period up to de-listment) for registration.
 - Further, if the company is found involved in manufacturing of LPG equipment after de-listment from OGRA's authorized manufacturers list then the company would be black listed hence cannot apply again for enlistment and legal proceeding would also be initiated against the company as per the prevailing laws.
 - You shall deposit pending amount of Rs1,524,000/- at your end in two equal installments of Rs762,000/- each by 15th December, 2024 and 15th December, 2025, as approved by the Authority else necessary action as per prevailing laws would be initiated you.
